World Hospice and Palliative Care Day (WHPCD) is a **global day of action** to celebrate and support hospice and palliative care around the world.

The theme for 2023 is Compassionate Communities: Together for Palliative Care. Compassion is defined as a strong feeling of empathy for people who are suffering and a desire to help them. The 'true meaning' of compassion is to recognise the suffering of others and then actually take action to help. There is a continued need to come together to support communities and each other now more than ever. Palliative care is a shared responsibility. Palliative care improves the quality of life of people facing serious illnesses, not just at the end of life but throughout the whole trajectory of the illness right from diagnosis. It also encompasses the health and well-being of caregivers which includes grief and bereavement support.

Compassionate communities care for people, assist people to live in the place they call home, connect people to services, and raise awareness about end-of-life issues. In recent years, hundreds of compassionate communities have been developed all around the world. We believe that palliative care working alongside compassionate communities multiplies the ability to respond to the needs of the most vulnerable in our communities.

#### **Overview**

Access to palliative care is a right to the highest standard of health and an integral component of universal health coverage for patients with serious illness and their caregivers. This innovative 2-day virtual Conference is a U.S.-based "coming together" that strives to foster cross-cultural community building and both scientific and experiential wisdom sharing. A multidisciplinary group of palliative care leaders at the forefront of research, policy, and clinical practice will present on diverse topics, including serious illness communication, palliative care needs of patients with cancer and other life-limiting illnesses, and care for historically minoritized and marginalized populations.

Condensed over two half-days, this year's virtual program includes:

- Special **breakout sessions** will include experts on bereavement, palliative sedation, serious illness communication, and palliative care in the non-cancer population.
- A highlight of this meeting will be dedicated sessions on the patient and caregiver experiences.
- A special Palliative Care Story Exchange will aim to bring together our global community to share openly, listen deeply, and find solace and meaning in our shared experiences as clinicians and caregivers.
- We will feature presentations from palliative care leaders across the world on methods for program implementation from Asia, Africa, and the Caribbean.
- Participants will engage in discussions with interprofessional and internationally based presenters about patient, family, and community implications for palliative care practice and scholarship.

The 2023 WHPCD theme, **Compassionate Communities: Together for Palliative Care**, will be a cornerstone throughout this year's conference.

This program is co-hosted by Memorial Sloan Kettering's **Supportive Care Service** and the **Department of Psychiatry and Behavioral Sciences**.
